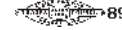

## SUMMARY ANNUAL REPORT FOR GREATER KANSAS CITY LABORERS VACATION PLAN

This is a summary of the annual report of the Greater Kansas City Laborers Vacation Plan, a welfare benefit plan (Employer Identification Number 48-6200960, Plan Number 501), for the plan year 11/01/2012 through 10/31/2013. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$3,554,604 as of the end of plan year, compared to \$667,285 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$2,887,319. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$5,595,044 including employer contributions of \$5,514,492, employee contributions of \$0, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$251. Plan expenses were \$2,707,725. These expenses included \$155,658 in administrative expenses, \$2,552,067 in benefits paid to participants and beneficiaries, and \$0 in other expenses.

4. Transactions in excess of 5 percent of the plan assets.
