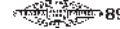

SUMMARY ANNUAL REPORT FOR GREATER KANSAS CITY LABORERS WELFARE PLAN

This is a summary of the annual report for the GREATER KANSAS CITY LABORERS WELFARE PLAN, EIN 43-6039074, Plan No. 501, for the period November 1, 2008 through October 31, 2009. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$21,475,127 as of October 31, 2009, compared to \$19,754,004 as of November 1, 2008. During the plan year the plan experienced an increase in its net assets of \$1,721,123. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$15,275,790 including employer contributions of \$13,226,838, employee contributions of \$871,547, realized losses of \$(32,953) from the sale of assets, earnings from investments of \$1,206,110, and other income of \$4,248.

Plan expenses were \$13,554,667. These expenses included \$1,324,309 in administrative expenses and \$12,230,358 in benefits paid to participants and beneficiaries.
